Support and care for people and families in the final stages of life is as important to our nation's health and wellbeing as a good beginning.

According to the Ipsos poll of 1540 Canadians conducted for phase 1 of *Palliative Care Matters: Listening to Canadians*, 51% of Canadians have had someone important to them receive palliative care within the past 10 years, while almost one-quarter (24%) of Canadians have been or are currently caregiving for someone important to them who was or is dealing with a life-threatening illness.

According to the Canadian Hospice and Palliative Care Association, only 15% to 30% of Canadians have access to palliative care, although 96% of them support it.

The need for quality, consistent, accessible palliative care for all Canadians is evident. Now is the time to come together to have this important discussion about the palliative care that we need and want in the future.

Covenant Health, Canada's largest Catholic health care organization and a key partner in Alberta's integrated health system, is pleased to host this initiative through our Palliative Institute as part of our efforts to champion a future where every Canadian has access to quality palliative care, and all caregivers are supported with the knowledge, expertise and resources they need.

We are grateful for the strong support and sponsorship of 14 national health related organizations, who have brought diverse perspectives, critical expertise and insights, and vital stakeholder experiences to the design and development of this initiative.

Background to the Palliative Care Matters Initiative

All Canadians will eventually need access to quality palliative and end-of-life care for themselves or their loved ones. The problem is that not all Canadians can access the care they require and as a nation, we don't have a national strategy for ensuring that people can access quality palliative care.

Covenant Health Palliative Institute has joined with many of Canada's leading national health organizations and experts in palliative care and health policy to draw Canadians into a national discussion on future directions for palliative care.

Palliative Care Matters started with a deep look at what Canadians think about palliative care and what support they are looking for. Through Ipsos research, 1540 Canadians were asked for their views and their insights. The results, along with research by national and international experts in palliative care, became the foundation for this next phase of the Initiative, the Consensus Development Conference.

At this Conference, members of the public join with experts to listen to the evidence around improving palliative care. A panel of interested citizens weighs the information and delivers a bold and thoughtful consensus statement. This statement brings together professional knowledge and powerful lived experiences into a series of recommendations for real, actionable change.

The work won't be over when the Conference closes. The consensus statement and the wisdom it contains will be analyzed by The Conference Board of Canada and by spring of 2017, The Conference Board will release a report outlining potential policy options and implementation plans to guide governments, healthcare organizations, professionals and other stakeholders.

Alberta, inaugural scientist for the Integrated Centre for Care Advancement through Research (iCARE, a joint venture of the University of Alberta and Capital Health, now Alberta Health Services) and research associate with the Socio-behavioural Research Centre (BC Cancer Agency). He supervises medical trainees, graduate students and teaches health economics, health finance and econometrics. Dr. Fassbender works with clinicians, administrators and policy makers to measure cost and performance associated with the financing and delivery of health care and social services. His research concentrates on the effects of health reform and technological change on health and economic outcomes of dying patients and their families.

Kevin Brazil



Kevin Brazil is a Professor of Palliative Care in the School of Nursing and Midwifery at Queen's University Belfast as well as a Professor (part-time) in the Department of Clinical Epidemiology & Biostatistics at McMaster University. After completing his BA (Hons)

and MA degrees at Carleton University, he completed his doctoral training at the University of Toronto's Ontario Institute for Studies in Education.

Dr. Brazil's research focuses on the structure, process, and outcomes in service delivery of quality care for family carers and patients as they near the end-of-life. As part of this work, he examines how personal, social, and environmental factors affect care. This work is designed to assist in the development, evaluation and translation of new and innovative interventions to improve access, quality and outcomes in this population.

James Downar



James Downar is a Critical
Care and Palliative Care
Physician at the University
Health Network in Toronto.
He graduated from McGill
Medical School and
completed residency training
in Internal Medicine, Critical
Care and Palliative Care at the

University of Toronto. He has a Master's degree in Bioethics from the Joint Centre for Bioethics at the University of Toronto. He is the Program Director for the Conjoint Residency Program in Palliative Care at the University of Toronto and the current chair of the Postgraduate Education Committee of the Canadian Society of Palliative Care Physicians.

Dr. Downar's research interests include communication and decision-making for seriously ill patients and their families; palliative care for the critically ill; and palliative care for noncancer illnesses.

Deborah Dudgeon



Deborah Dudgeon is the W. Ford Connell Professor of Palliative Care Medicine and Professor of Medicine and Oncology at Queen's University. She is the Head of the Palliative Care Medicine Program for Queen's University and

Kingston General Hospital and has been in this position since 1997. Dr. Dudgeon is the co-chair of the Advisory Committee on Palliative Medicine for the Conjoint Training Program of the Royal College of Physicians and Surgeons of Canada and the College of Family Physicians of Canada. She is a Past President of the Canadian Society of Palliative Care Physicians, and was the Provincial Program Head for Palliative Care for Cancer Care Ontario from 2004 to 2010. She also served as the co-chair of the Symptom Control Committee of the National Cancer Institute of Canada Clinical Trials Group and a member of the Advisory Committee on Research for the National Cancer Institute of Canada.

Dr. Dudgeon's main research interests relate to the etiology of dyspnea in cancer patients and health services research related to care of the advanced cancer patient.





R. Sean Morrison



Sean Morrison is Director of the Lilian and Benjamin Hertzberg Palliative Care Institute and the National Palliative Care Research Center, organizations devoted to improving care for persons with serious illness and their families and

enhancing the knowledge base of palliative care in the United States. He is also Professor of Geriatrics and Palliative Medicine, and Hermann Merkin Professor of Palliative Medicine in the Brookdale Department of Geriatrics and Palliative Medicine at the Icahn School of Medicine at Mount Sinai. During 2009-2010, he served as President of the American Academy of Hospice and Palliative Medicine. He is the recipient of numerous awards, including the American Academy of Hospice and Palliative Medicine's 2010 PDIA National Leadership Award and the 2013 Excellence in Scientific Research Award. He has received over \$45 million dollars in research funding and published over 125 research articles.

Dr. Morrison's current research focuses on improving the management of pain in older adults and on developing and evaluating models of palliative care delivery in hospitals and the community.

Barbara Pesut



Barbara Pesut is an Associate Professor in the School of Nursing at the University of British Columbia. She holds a Canada Research Chair (Tier 2) in Health, Ethics and Diversity. In 2012, Dr. Pesut received the College of Registered Nurses Award of

Excellence in Nursing Research.

Dr. Pesut's program of research explores the implications of religious, spiritual and geographic diversity for palliative care. Recent projects have examined ethical issues in rural palliative care, palliative family caregiving and educating nurses for a palliative approach. She is currently conducting a trial of nurse navigation to better support rural palliative patients and their family caregivers.

Hsien Seow



Hsien Seow is the Canada Research Chair in Palliative Care and Health System Innovation and an Associate Professor in the Department of Oncology, McMaster University. He is also the ICES McMaster Site Director. Previously he held a

CIHR New Investigator award and the Cancer Care Ontario Chair in Health Services Research. He earned a PhD is from Johns Hopkins School of Public Health and a BSc from Yale University. His research interests are innovating the palliative care health system and improving quality of care. He has worked with RAND Health, Ontario Ministry of Health and Long-Term Care, Health Quality Ontario, various health policy makers to improve hospice palliative care.



Jane Seymour



Jane Seymour qualified as a nurse in 1982 and gained a PhD from the University of Sheffield in 1994. In April 2016, she rejoined the University of Sheffield as Professor of Palliative and End-of-Life Care following ten years at the University of

Nottingham as the leader of the Sue Ryder Care Centre for the Study of Supportive, Palliative and End-of-Life Care. Dr. Seymour holds an Honorary Chair at the University of Queensland, Australia and was awarded a lifetime achievement award for her research in 2014 by the International Journal of Palliative Nursing. She has contributed to research grants and awards totaling over £7.5 million and has published over 140 outputs in peer reviewed journals. Dr. Seymour's current research interests include advance care planning and end-of-life decision-making, palliative and end-of-life care in resource poor contexts nationally and internationally, and public education for end-of-life care.


Allison Williams



Born and raised in Halifax, Jim Mulcahy has spent the bulk of his adult years in Antigonish, a small university town in North-Eastern Nova Scotia where he taught English and drama in the local public school system for over thirty years. Forced to retire from teaching after his

second cancer diagnosis, Mr. Mulcahy became actively engaged as a patient advocate serving on a variety of local, provincial, and national healthcare committees. He has been the keynote speaker at a number of provincial and national hospice/palliative care conferences and was recently awarded an honourary doctoral degree from St. Francis Xavier University in recognition of his contributions as an educator, and patient advocate. For the past twelve years Mr. Mulcahy has been the primary care giver for his wife, Sarah, who is in the latter stages of Huntingtons. Three of their four adult children have also been diagnosed with the same illness, and a year ago, their three year old grandchild was diagnosed with an incurable, life threatening blood disorder. Mr. Mulcahy and his family were the subject of "A Story of Care", a palliative care resource video produced by the Canadian Virtual Hospice and the Canadian Association of Schools of Nursing.

communications and public affairs research for a wide variety of public and private sector clients, as well as for a




